

Enrollment for 3Ls opens at 7:00 am on Thursday, November 7th.

Enrollment for 2Ls opens at 7:00 am on Friday, November 8th.

Becky will enroll 1Ls the following week.

Enroll on ONE (<https://one.ou.edu/>), directly from the Academic tab on your page, after logging in.

****Check for any enrollment holds on your account and that ONE has your enrollment date correctly listed BEFORE Nov 7-8, as there is no one on main campus at 7:00 am to handle any issues the day of!!**

- If participating in a **law review or competition**, please enroll yourself if taking it for credit.
- All classes should have a waitlist on ONE, so add yourself to it if the class you want to take is full.
- **Course Descriptions** and **prerequisites** can be found on Courtyard.
- You will need an override to enroll in **Advanced Legal Research** and/or **Advanced Persuasive Writing**, as ONE does not yet recognize *Brief Writing* and *Oral Advocacy* as satisfying the prerequisites. Email Becky (rlucas@ou.edu) beforehand, so you don't miss out enrolling in these courses.
- **Corporations** CANNOT be taken by a student who has taken or is planning to take **Business Associations**, and vice versa. Only one of these courses will be counted per student.
- **Practical Lawyering & MPTs** is for 3Ls only.
- Although the system will not block you from enrolling, please note that **Special Topics in Indian Law Seminar** has a prerequisite of *Federal Indian Law*. Becky will have to drop anyone from the seminar that has not taken *Federal Indian Law* first.

New classes to note:

Statutory Interpretation Research & Writing Lab: Prerequisite: Previous completion or concurrent enrollment in Statutory Interpretation.

Through guided instruction and simulated research and writing exercises, students will develop the skills to effectively research statutory materials and communicate their statutory interpretations clearly and persuasively to legal practitioners, clients, judges, and other stakeholders.

Legislation Seminar: This course will study the legislative process and the forces underlying that process including: where ideas for legislation originate, bill drafting, the committee process, amendments, internal and external lobbying, campaigning for office, and other relevant issues. The course will explore these topics through examples of major legislative reforms in Oklahoma and other states. The course will include a discussion of constitutional, statutory, and internal rules governing the Oklahoma Legislature. The course will also include a comparison of the Oklahoma legislative process to the processes of other state legislatures.

Special Topics in Indian Law Seminar: Prerequisite: Federal Indian Law. This course provides an in-depth examination of current legal issues in Indian country, including tribal governance, treaty rights, criminal and civil jurisdiction, the scope of the Federal-Tribal trust responsibility, tribal courts, and other contemporary topics. Students will analyze complex legal issues in Indian country and explore the relationship between federal and tribal law. Students will analyze current legal issues in Indian country and their impact on tribal sovereignty and self-determination, assess the tribal/state/federal intersection of legal issues, and consider strategies for representing clients in Indian country.

ENROLLMENT PERMISSIONS:

****To enroll in more than one course with the same 4-digit course number (i.e., 2 or more 6100 or 6700 courses), requires permission on ONE. Email Becky (rlucas@ou.edu) the titles or section numbers of the courses you want to take, for overrides. Easier to do this BEFORE enrollment, to not to lose your chance to enroll in a timely manner on the day of!!**

Students enrolling in the Lab must also have taken or be concurrently enrolled in the *Statutory Interpretation* class with Professor Pearl. If approved for the Lab, Becky will enroll those approved for the lab, and also for the class if need be.
- Email Professor Baca (abaca@ou.edu) to apply to enroll in the **Legal Spanish** course. He will schedule an interview to assess your Spanish language proficiency before permitting you to enroll. Becky will enroll those approved.
- Email Dean Taite (phyllis.taite@ou.edu) for permission to enroll in the **American Indian Estates Clinic** and/or the 1 hr. **American Indian Estates** class. Students enrolling in the Clinic for the first time must also enroll in the companion *American Indian Estates* 1-hr. course, but students may also enroll in the *American Indian Estates* 1-hr. course by itself—either way you need permission. The *American Indian Estates* 1-hr. course is scheduled from 9:00 am-2:30 pm on the Sat & Sun (Jan.

11-12) before other classes begin, and from 7:00-8:00 pm on three Wednesdays (Feb. 12, March 12, and April 16). Becky will enroll those approved.

- Email Dean Taite (phyllis.taite@ou.edu) for permission to enroll in **Directed Legal Research**. Please copy the Professor who has committed to supervise your research on the email. Also identify if the enrollment will be used to satisfy your Graduation Writing Requirement and explain why you need to enroll in a DLR to complete your project (i.e., why you cannot write your paper in an existing seminar). Becky will enroll those approved.

The 1 hr. class will meet from 9:00 am to 1:00 pm on Sat., Jan 25th, from 6:00-10:00 pm on Mon., Feb. 17, AND from 6:00-9:00 pm on both Mon, Mar. 10 and Mon., Apr. 14. Becky will enroll those approved.
